GIFT PLANNING SUSTAINS OUR MISSION

In order to ensure a sound financial future for Seasons Hospice, we rely on the generosity of our donors.

There are many ways to make a lasting gift to Seasons Hospice and the following options represent the most common gift giving opportunities.

CASH GIFT

Giving a cash gift makes an immediate positive impact for Seasons Hospice and may provide you with an income tax deduction.

APPRECIATED PROPERTY

Donate securities or real estate that you have owned for over a year and avoid capital gains tax on appreciation. You also may qualify for a charitable income tax deduction equal to the full value of the donated assets.

RETIREMENT PLAN ASSETS

Name Seasons Hospice as beneficiary of part or all of your IRA or retirement plan. This can result in income tax savings and, in some cases, estate tax savings as well.

LIFE INSURANCE POLICY

Name Seasons Hospice as beneficiary of your life insurance policy. This also could result in estate tax savings for your heirs during your lifetime. You may donate a policy that you no longer need and qualify for an itemized income tax deduction.

ENDOWMENT

Endowment funds continue your gift to Seasons Hospice in perpetuity, providing income from the principal which is invested. You may perpetuate your annual gift or participate in funds which are designed for specific purposes.

BEQUESTS

A bequest is a gift in which you name a charitable organization, such as Seasons Hospice, a beneficiary of your will or trust. A bequest can be a specific monetary amount, a percentage of your trust or estate, a specific piece of property, or a percentage of the "residue" of your estate. The following is sample bequest language, which may be adapted by your legal counsel to fit your individual circumstances:

"I hereby give to Seasons Hospice, Federal Tax I.D. number 41-1812914, located at 1696 Greenview Drive SW, Rochester, Minnesota, 55902, the sum of \$ ____ or ____% of my estate or property herein described, for the benefit of Seasons Hospice, to be used by its Board of Directors as it may deem advisable."

CHARITABLE GIFT ANNUITY

Funded with cash or appreciated securities, a charitable gift annuity permits you to make a gift now and receive income for life for one or two persons. You may take advantage of a current income tax charitable deduction and payments may be treated favorably for income tax purposes. The remainder continues to provide income to Seasons Hospice in perpetuity.

CHARITABLE REMAINDER TRUST

Creates a retirement plan that offers maximum income to you and makes a deferred charitable gift to Seasons Hospice.

SEEK PROFESSIONAL ADVICE

For additional information about specific planned giving vehicles, please consult with your attorney, accountant or estate planning advisor about your individual needs. All gifts must be in accordance with the Seasons Hospice Gift Acceptance Policy and are subject to final approval by the Seasons Hospice Board of Directors.
